WCMGA Program Director Update, April 11, 2024

1. Monthly Speaker Committee:

The April Chapter Meeting webinar attendance: 82 adults for Darren Morgan's presentation: **The Vegetable Underground: A Guide to Growing Root Crops** including 47 MGs who stayed for the chapter meeting.

2. **Chapter Gardens:** Have implemented their new night light monitors for the Dark Sky project, are spending down the JYT grant funds, and preparing for their family friendly Saturday Open Garden and Garden Fair events in June. And a group of MGs from the Central Gorge MGA attending the Perennials IGS class at PCC RC on 6/15 plan to tour both gardens that day as well.

3. Community Collaboration, Education and Outreach:

- The **Home Plate** team has resumed training sessions with youth at Home Plate.
- Grow 1 Give 1: Peppers and tomato seeds are up and growing. The project is setting up six delivery sites for mid -May through early June.
- **Hortlandia 2024:** MGs staffed the Friday evening and Saturday event making _103 contacts over the event which had a total attendance of ____(TBD)_____.
- **OSU Extension's Grow This** seed distribution package for WCMGA arrived in late March and will be offered at multiple events this spring and summer, including the Volunteer Opportunities Fair on 4/21, G1-G1, the Garden Fair, Farmers Markets, and community events, etc.

4. Chapter Program Operations:

- Chapter Activity Tracking: The new tracking system is working well. No need to remind folks to submit their counts.
- The MG 2024 Volunteer Opportunities list has been updated on the chapter's members portal of the website.
- **Chapter public facing presentations:** Susan Albright has sent out a master template for presentations including a couple of opening slides on OSU Ext and the MG program that we'll also need printed up for outdoor presentations.
- **OSU Extension Metro MG 2024 Volunteer Activity Proposal i**s now available for chapter activity leads to use for proposed new activities.
 - 2024 OSU Extension Master Gardener™ Volunteer Activity Proposal. The report form is not yet accessible.

5. New opportunities:

- Tualatin Soil and Water Conservation District's education specialist, Adriana Lovell met briefly with Marilyn and Srijana Shrestha to see the Extension Education Services office and provide copies of a new brochure about the Oregon White Oak,
- **National Alliance on Mental Illness of Washington County (NAMI)** MGs will provide a provide a Let's Talk Plants table with seeds and planting activity on April 22 with a focus on container gardening, vegetables and pollinators.
- **Soil pH testing** is being explored as an additional outreach tool and public service. Minoo Sweet, a chemist before she became a MG, is looking into recommended methods and testing the meter purchased pre COVID.
- **Food Hero materials:** We have printed culturally specific recipes from the Food Hero website for periodic posting near growing ingredients in the Learning Garden. Food Hero crop specific growing tips pages will also be laminated for similar use. Maureen Quinn of OSU Extension's Food Hero program has allowed WCMGA to print off 300 copies of FH materials for outreach and education activities in Washington County using the Food Hero printing number. And, Leann Locher, of MG and Food Hero, will be our May monthly chapter meeting speaker.

- The Meto Program office will list the **Hillsboro Pride Party** MG Booth in Cervis for MG sign up if the opportunity is approved so it will be a Metro Program offering.
- Washington County 2024 Farmers Markets arrangements are still in planning. Beaverton and Cedar Mill Markets are on, likely either weekly or every other week. No decision has been reached yet on Hillsboro or Aloha Markets.
