BOARD REPORTS

- OSU Support

 - 2) Connie moved to approve \$7500 as the amount of support for 2026. The motion was seconded and passed by the Board.
- OMGA Dues and Donation- The draft will be adjusted to show that the dues for 2026 are the same as for 2025.
- Technology and Hardware- The cost of Zoom was reviewed.
- Issue Office/General Administration Expenditures- The Historian fund was unused in 2025. It will be removed for 2026.
